COST: Entry fee is **\$15.00 for one day** or **\$20.00 for both days** for an 8' x 10' space. Electricity is available. Bring your own tables, shelves, hooks, material for back-drop or enclosing. **NOTE:** All spaces are the same fee. **NO REFUNDS** after September 26, 2008.

GENERAL: All arts and crafts items must be handmade. No foreign or machine made items for sale. All entries must be accompanied by picture or description of your art or craft. Inside 4-H Building spaces are on **"first entry"** basis - 24 are available. Outside spaces are under covered barn. If you request further information it will only be answered by sending self-addressed stamped envelope. **DEADLINE FOR ENTRY IS SEPTEMBER 27, 2008.**

CAMPING: All overnight parking permitted Friday and Saturday. Camping is free but a \$10.00 fee for electric hookup will be collected. Motel accommodations are available.
